

**TOWN OF SHARPSBURG  
MINUTES OF THE TOWN COUNCIL MEETING**

**October 23, 2006**

A regular meeting of the Sharpsburg Town Council was held Monday, October 23, 2006, at 7:00pm, in the Town of Sharpsburg at the Bridges Recreation Center.

Present were the following: Wendell Staley, Mayor; Larry Hyde, Council Member; Clay Cole, Council Member; Stan Parten, Council Member; Robin Spradlin, Town Administrator and Donna Camp, Town Clerk. Council Member McElwaney was absent.

Mayor Staley called the meeting to order at 7:00 pm.

The pledge of allegiance was recited.

The Town Clerk verified there was a quorum present.

The minutes of the Council Meeting and Public Hearings held on October 2, 2006 were reviewed and approved.

Mayor Staley presented a resolution to deny the petition from the Association of County Commissioners of Georgia to the Georgia Public Service Commission that if granted would result in municipal franchise fee being collected only from municipal customers. Council Member Cole motioned to approve the resolution. Council Member Hyde seconded. Motion carried, unanimously.

Mayor Staley called for a motion to accept and adopt the Fee Schedule for Development and Building permits for the Town. Council Member Parten motioned to approve and adopt the schedule of fees. Council Member Hyde seconded. Motion carried, unanimously.

Administrator's Report -

- The 2006-2026 Comprehensive Plan for the Town has been completed and accepted by the Department of Community Affairs. The next update to the Comp. Plan will be in 10 years unless an update is needed sooner. Copies are available for review at the Town Hall office and the Library.
- Friday, November 17, 2006 will be the Christmas Tree Lighting being sponsored by the Sharpsburg Merchants Association. Santa will be on hand to turn on the lights and the merchants will have booths set up for shopping. The Quilting Ladies will have a quilt up for raffle. Please try to attend and start the holiday season off right!

Mayor Staley polled the Council for comments - There were none.

Mayor's Minutes - There were none.

Public Comments - There were none.

Council Member Parten motioned to adjourn the regular meeting and proceed into Executive Session for discussion of personnel matters. Council Member Cole seconded. Motion carried, unanimously.

Council Member Hyde motioned to adjourn the Executive Session and return to the regular meeting of the Council. Council Member Cole seconded. Motion carried, unanimously.

Mayor Staley called for a motion to accept and adopt the contract for employment for Robin L. Spradlin, Town Administrator. Council Member Parten motioned to accept and adopt the contract. Council Member Cole seconded. Motion carried, unanimously.

There being no further business coming before the Council, the meeting was adjourned.
