

**TOWN OF SHARPSBURG  
MINUTES OF THE TOWN COUNCIL MEETING**

**July 6, 2015**

A regular scheduled meeting of the Sharpsburg Town Council was held Monday, July 6, 2015, at 7:00pm, in the Town of Sharpsburg at the Sharpsburg Recreation Center.

Present were the following: Wendell Staley, Mayor; Derrick McElwaney, Council Member; Clay Cole, Council Member; Celene Davenport, Council Member; Donna Camp, Town Clerk. Council Member Rhodes was absent.

Also in attendance were: Margaret Staley, Eric Richards, Dillon Davenport, Mr. & Mrs. Lassiter, Joe Bridges and Polly & Shelby Garlington.

The Mayor verified there was a quorum present.

The minutes of the May 4, 2015 Council Meeting were reviewed and Council Member Davenport motioned and Council Member Cole seconded. Council Member Davenport wanted to know if changes were made between a 1<sup>st</sup> and 2<sup>nd</sup> reading of an ordinance, are you suppose to have 1<sup>st</sup> reading again? No, changes to an ordinance in between readings are allowed. Motion carried unanimously and will be filed in the minute book.

Mayor Staley called for a motion to accept the bid from Coweta County to help with the demolition and construction of the park. Council Member Davenport motioned to accept the bid, Council Member McElwaney seconded. Council Member Davenport would like to see if we can donate the lights or if any organization would want them. It was suggested to put them on Access Coweta, ask a football league or a church if they would want them. Motion carried, unanimously.

Mayor Staley called for a motion to allow the Mayor to sign the intergovernmental agreement with the county to allow them to work on our park. Council Member Davenport motioned to approve and Council Member Cole seconded. Motion carried, unanimously.

Mayor Staley called for a motion to allow the Mayor to sign the right of entry with Coweta County allowing them access to our property while working on the park. Council Member McElwaney motioned to accept and Council Member Cole seconded. Motion carried, unanimously.

Cash Management Policy - Council Member Davenport would like the paragraph page 3 B to be changed to exclude the Mayor from being a part of 2/3's vote of the Finance Committee. Council Member Davenport wants all purchases that do not have a direct benefit to the town to go before the town council.
