

**TOWN OF SHARPSBURG
MINUTES OF THE TOWN COUNCIL MEETING**

March 6, 2017

A regular scheduled meeting of the Sharpsburg Town Council was held Monday, March 6, 2017, at 6:00pm, at the Sharpsburg Recreation Center.

Present were the following: Wendell Staley, Mayor; Stan Parten, Council Member; Clay Cole, Council Member; Polly Garlington, Council Member; Donna Camp, Town Clerk. Council Member Rhodes was absent.

The Pledge of Allegiance was delivered.

The Clerk verified there was a quorum present.

The minutes of the February 6, 2017 Worksession and Council Meeting were reviewed and approved by unanimous vote, and were filed in the minute book of the Town.

Mayor Staley called for a motion to accept and adopt second reading of Environmental Control Ordinance Amendment concerning open burning. Copies of ordinance were previously presented to Council and were available for inspection by public. Council Member Garlington motioned to accept and adopt the ordinance, Council Member Cole seconded. Motion carried, unanimously.

Mayor Staley called for a motion to enter into an Intergovernmental Agreement with Coweta County for Animal Control Services and to allow the Mayor to sign the agreement. Council Member Cole motioned to enter into the agreement, Council Member Garlington seconded. Motion carried, unanimously.

Mayor Staley called for a motion to enter into an Intergovernmental Agreement with Coweta County for Animal Shelter Services and to allow the Mayor to sign the agreement. Council Member Parten motioned to enter into the agreement, Council Member Garlington seconded. Motion carried, unanimously.

Mayor Staley called for a motion to purchase an AED for the recreation center. A copy of the bid will be attached to these minutes. Council Member Cole motioned to purchase the cheapest AED which was recommended for the recreation center from Mr. Sam Conner. Council Member Garlington seconded. Motion carried, unanimously.

Mayor Staley discussed the construction of the gazebo and asked for a motion to move forward with the project. The builder will be busy after April and the town has the funding for the project. The project should be completed in the next month. Council Member Parten motioned to begin construction as soon as possible, Council Member Cole seconded. Motion carried, unanimously.

Old Business -

Water Contract - The town changes some wording to the contract and will be getting together with the Mayor of Turin hopefully this week. Hope to call a joint meeting with Turin to finalize by the end of the month.

Picnic Tables - The town applied for a grant with Lowe's and they agreed to provide the material for 4 tables with delivery. They also gave a discount on the material for the remained of the tables. Currently putting together, the first table as a template then we will cut all the wood and stain it this weekend.

Playground - The town has requested Coweta County to bring dirt into the area for fill along with compacting the dirt. The Commissioners will be voting on the request.
